***BUT, we all have to follow some guidelines to ensure a Positive Vibe for Everyone! ...
So here comes the fine print :)***

Booking & Cancellations

- 50% Deposit required to secure session date & time for all new clients.
- Sessions booked within 24 hours are subject to a 50% increase on booked session hours only. (Negotiable)
- Any sessions canceled within 48 hours of booking, a charge equal for the session hours booked will be invoiced to the client.
- Materials, Data and File content storage at DogManic Recording Studios is provided for client's convenience.
- All sensitive media content gets deleted between 30 - 90 days following your session, unless otherwise specified.
- For all commercial clients, we follow all Sag-Aftra & NDA and security protocols.
- Any risk to the safety of materials, after delivery, are solely the responsibility of the client.

Session Rules and Guidelines

- No smoking inside the Studio. (Vaping allowed in the Green Room only)
- No firearms allowed on premises at any time.
- No food is allowed past the Lounge / Green Room.
- Only beverages with a tight fitting lid or capped bottle are allowed past the Green Room.
- Studio shall have final say on proper and safe methods of use for all of its equipment and facilities.
- Our Staff will be present to help organize equipment, and set up / move all Microphones.
- The Client is responsible for any damage they cause to the Studio equipment or property.
- If you notice something damaged, please advise the Studio Staff promptly.
- Client agrees to indemnify Studio and employees and hold harmless from any self-inflicted injuries, claims, costs, losses, detriments and expenses incurred by Client and their associates.
- Studio is not responsible for any of the Client's property that is left on the premises.
But as part of our Studio standards, we always do a final walkthrough a.k.a. idiot check and we will secure anything left behind & notify the client promptly.
- Our Studio reserves the right to refuse work to anyone who disregards Our Policies.

We Maintain a Clean, Healthy, and Comfortable Work Environment.

IF for any reason the Studio Manager decides that the client is not respecting our facility or has caused an unacceptable mess, a \$100.00 clean up fee will be collected @ the end of the session.
